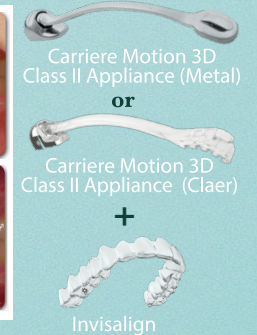

## Synopsis

Our office started to use Aligner Orthodontics since 2006. We focus to approach adult patients who are more concerned about the esthetic. They are reluctant to choose the conventional orthodontic appliance. However, 68% of our Aligner patients are growing children. In order to expand the limit of Aligner Treatment, some auxiliaries are necessary. The Carriere Motion 3D Class II & Class III Appliances are one of the appliances that can be synchronized with mixed dentition case as well as adult case. We will discuss how we manage the transverse problem as well as the vertical influence during the distalization of the molars before Aligner Treatment.
