Up to now, there has been a lot of attention given to molar distalization, while molar protraction has been left out of the discussion for the most part. This lecture deals with 2nd molar protraction of L-6 (Lower 1st molar missing), L-E (E missing with 2nd molar missing), and U-6 (Upper 1st molar missing). After 2nd molar protraction, even a horizontally-impacted 3rd molar can be uprighted. The existing researches about the 3rd molar have been about its movement after 2nd molar extraction. This lecture is totally different from those because it deals with research after 2nd molar protraction rather than extraction. This 8-hour lecture concentrates on only "Molar protraction." Molar protraction can be used very widely, not only with orthodontic patients, but also with general dental patients with a damaged molar. It can be a successful new area in the field of orthodontics. Among the 260 cases, 2 cases were selected as "Case of Month of AJODO" (June 2012 and March 2017). Also, in July 2017 in JCO, the case of simultaneuous missing space closure of the 2nd premolar and the 1st molar was published. He has also studied the spontaneous movement of an impacted 3rd molar after 2nd molar protraction. The first original article was published in Angle Orthodontists in July 2016. Also, the 2nd original article is now in the middle of revision at AJODO. He also wrote an English book that is being sold on Amazon. This book was introduced in the Book review corner of JCO, Feb. 2014. Dr. Neal Kravitz praised Dr. Baik as the "Master of Molar Protraction." Dr. Baik has treated 260 cases of L-6, L-E and U-6 totally by himself, while the other author only contributed article writing.
